Subject: Investment clearance to revised cost estimate (RCE) of the Jamrani Dam multipurpose project, Uttarakhand. (estimated cost Rs 2584.10 crore at May 2018 price level, benefit cost ratio 1.09:1)

The undersigned is directed to convey that on recommendation of the Investment Clearance Committee in its 17th meeting held on 10.06.2022, the investment clearance to the project proposal of **revised cost estimate (RCE) of the Jamrani Dam multipurpose project, Uttarakhand**, with estimated cost of Rs 2584.10 crore at price level of May 2018, has been considered acceptable for investment in State Plan, subject to conditions stipulated in the 141st Meeting of the Advisory Committee on Irrigation, Flood Control and Multipurpose Projects under DoWR, RD&GR held on 11.02.2019 and other general conditions as mentioned below.

General Conditions:

- i. Investment clearance thus accorded does not make the project eligible/entitled for any kind of central assistance under centrally sponsored/ central sector schemes, unless otherwise already committed by Union Government.
- ii. All the mandatory / statutory clearance from various Ministries / Departments / Organisations is to be obtained by Project Authority.
- iii. The project may be completed by March 2027, with benefit cost ratio and total cost being valid for this period only. Project may accordingly be executed as per the approved outlays in the State annual plans. The State Finance Department may restrict the expenditure to the approved cost i.e. Rs 2584.10 crore at May 2018 price level, and no additional expenditure beyond approved cost may be permitted unless the revised estimate is got approved following the prescribed procedure.
- iv. Design aspects shall be adequately addressed by the project authority during construction of the project.
