Dear Sir,

As you may be aware that provision of Section-31(2) of the Central GST Act, 2017 and its relevant provision in the Uttarakhand GST Act & Uttarakhand GST Rules 2017 clearly provides that a registered person supplying taxable services shall issue a tax invoice showing the description, value and tax charged thereon.

In this context, it has come to my notice that compliance of this provision of CGST/SGST is not being ensured in the State while taking services of the contractors for execution of Government works. Neither the tax invoices are being issued/submitted by the contractors while raising their bills for executed works nor submission of the same has been become mandatory by the concerned government construction agencies. Consequently, there remained possibility of inordinate charging/payment of GST by the contractors and tracking of the same at institutional level is an impossible task.

In light ~~the~~ of above, I request you to direct all the government construction agencies (PWD, Irrigation & MI, RWD, Peyjal Nigam, Jal Sansthan, BRIDCUL, SIDCUL, GMVN, KMVN, UPCL, PTCUL, UJVNL, PMGSY etc.) and the Director Treasuries to make payment to the contractors only after obtaining of the tax invoices from them.
